

Bristol Miniday Conditions of Booking

Please read the following carefully before signing and sending in your completed application form.

- Traders are responsible for the security of their personal safety, belongings, goods, vehicles and trade stand – we strongly advise that all traders carry an appropriate fire extinguisher.
- There is no electricity on site. All fuel brought in must be held in the proper container and all generators must have at least one appropriate fire extinguisher.
- All traders must carry Public Liability Insurance for a minimum of £5m valid for the entire period of the show *
- All traders must complete a current Risk Assessment specific to their business
- All traders must be on site by 9.30am on show days– NO vehicle movement is allowed whilst the show is open to the public.
- Compliance with the current Disabilities Discrimination Act is the responsibility of individual traders.
- Sub letting of trade space is strictly prohibited
- The sale or use of fireworks, firearms, quad bikes, motorised scooters, motorised skateboards, motor bikes (of any size) is strictly prohibited.
- The selling of food and drink (other than by designated caterers) is strictly prohibited.
- Trade plots must be left clear, clean and tidy by 6pm Sunday. Traders are responsible for removing all their trade waste from the site.
- All accidents must be reported to the Information Point.
- The person/s booking the trade plot will be held solely responsible for the behaviour of any person associated with them.
